




Tip 1: The window of opportunity

- As tobacco control policies are formulated and implemented, it is important that policies undergo rigorous evaluation.
- The Tobacco Products Directive (TPD), and the WHO Framework Convention on Tobacco Control (FCTC).
- These two instruments provide the EU Member States with the framework of actions.
- Unique window of opportunity to be able to evaluate this large natural experiment.

Why European Funding?

- ✓ Impossible to do with any other funding mechanism
- ✓ European focused project
- ✓ Large amount of funding was needed
- ✓ Prestige / scientific trust
- ✓ Career development path



Tip 2: Selection of partners

- ✓ Research is a "team sport"
- Choose partners with whom you have collaborated
 - Extensively
 - Cooperatively
 - Had a "good time"
 - It's a loooooooong process
 - Do NOT randomly select your partners
- ✓ The aim of the H2020 is to enhance European wide collaborations

Tip 3: Patience & understanding

- Project management is people management
 - Cultural aspects
 - Personality aspects
 - Win/win situation
 - Team spirit



Tip 4: Engagement of researchers

- ✓ Gender Balance
- ✓ Researcher capacity/expertise balance
- ✓ Each researcher must fit into the "machine"
- ✓ Researcher experience balance
 - ✓ Junior/senior
- ✓ Engagement of junior researchers



Tip 5: Grant writing (1)

- ✓ Start early, plan ahead
- ✓ Delegate tasks
- ✓ Ask partners to contribute based on their expertise
- ✓ DO NOT OVERPROMISE.
- ✓ Grant agreement is the "holy text"
- ✓ Special hint:
 - Get help of an experienced budget manager
 - Care with ethics and the necessary supporting documents

Tip 5: Grant writing (2)

Context

- Attention to the scope of call
- Peer reviewers may not be exact topics

Budget

- Negotiate early on budget
- Allocate according to tasks

Rules

- Organise internal agreements early on
- Make sure everyone agrees early on



Tip 6: During the project

- ✓ Consult your project officer!!
- ✓ Build in the learning curve
- Continuous monitoring and updating against milestones
- ✓ Ensure quality vs. time (don't cut corners)
- ✓ Have a structured decision process
- ✓ Remember it is a "team sport"
