- •SME budget share: 51%






Remarks on short-list

- Work together with the European Commission, with relevant legislative and standardisation initiatives and with national, regional and local authorities for more favourable regulatory and standardisation conditions, innovative procurement and incentive mechanisms.




Retained proposal: Partners per country
