Facts and figures

PHC-26 (RIA, threshold 12)

- Budget EUR 59,6M
- 253 eligible proposals requesting EUR 1.1 billion

PHC-34 (CSA, threshold 12)

- Budget EUR 4M
- 7 eligible proposals requesting EUR 7.9M



PHC-26-2014 Area Coverage

- 29% for topic (i): Citizen engagement in health, wellbeing and prevention of diseases
- 71 % for topic(ii): mHealth applications for disease management




Coverage, cont...

- number of proposals in the 2nd area roughly 50% higher than in the 1st one
- large number of medical and/or non-medical disciplines (e.g. cardiology, diabetes, chronic diseases, cardiovascular diseases, cancer, geriatrics, psychology, psychiatry, nutrition, fitness, etc.)
- (integrated or/and web-based) services and functionalities (apps, games, etc.)
- mobile devices used to interact with the platforms
- often envisaged outcome is software with different functionalities
- users diagnosed with a specific condition/disease/disorder, or project specifically targeted at patients or healthy people
- target caregivers (formal or informal, different age groups) as well as health and care professionals



PHC-26: Participants countries



 51% from universities and research institutes (public or private), 18% from private commercial firms and 31% came from "Other" fields.




PHC-34-2014 Area Coverage

- (i) Standardization: Common reference information model for eHealth deployment
- (ii) ePrescriptions: Common data model/vocabulary for medicinal or pharmaceutical products
- (iii) SNOMED: Detailed analysis on the advantages and disadvantages, as well as the impact of using SNOMED CT as the core terminology at the EU level
- (iv) CEF: Identification of right business models and plans which would determine sustainable sources of revenue and costs




PHC-34: Participants countries
